With reference to the above subject and reference, all final semester students of UG and PG programs are required to submit their convocation application forms through the online mode.


In this regard, Heads of Departments are kindly requested to ensure that the convocation application forms are filled and submitted by the students within the stipulated deadline.




- All candidates who appearing for final semester examinations of UG and PG programs are eligible to apply for **25th Annual Convocation**.
