This includes installation, commissioning, testing & up keep of the complete link for one year period. It is to ensure that PESCE is getting 50 Mbps (1:1) bandwidth uninterruptedly. • The hardware and software required for the establishment of fully functional leased line will be provided by the bidder. • The bidder should have valid license from DOT as applicable for providing internet services in claimed location like ISP class A or Class B. (Attach a copy of license). • The bidder would insure that the local loop provisioning does not violate regulations as laid by Government of India/TRAI in respect of such links/networks.
